The Foundation awarded 28 undergraduate and graduate scholarships and awards during FY 2025 and also provided leadership development programs that focused on preparing students to make a positive impact on their campus and community. These programs included the annual leadership conference, volunteer leadership projects, leadership workshops, cohort groups and mentoring support. In addition, the Legacy Foundation provided support and resources to Phillips University alumni, including through alumni gatherings and the PU Oral History Project. \$5011.70 of program revenue was pass-through income in support of alumni events. The Foundation had 19 volunteers who donated a total of 1,882 hours of volunteer service.

Board members are required annually to complete a conflict of interest questionnaire. In the event a conflict arises, the board member notifies the board and appropriate actions are taken.

Form 990, Part VI, Section B, Line 15:
A compensation committee reviewed executive director compensation, as well as other officers and key employees. They consulted the Forms 990 of other oragnizations as well as compensation surveys. The final compensation was approved by the board.

Form 990, Part VI, Section C, Line 19:
The organization's governing documents, conflict of interest policy, and financial statements are available to the public upon request.

Schedule D, Part V, Line 1a
During the fiscal year, the Foundation corrected a prior period classification error related to \$156,207 previously included in endowment balances on Schedule D. The funds originated from oil and gas revenue received through a merger and were neither donor derived nor endowed, but were misclassified as such following the merger. The balance was corrected in the current year to reflect proper classification. This adjustment reflects a classification correction only and did not affect total net assets, donor restrictions, or expenditures.
